In response to questions 2, 3 & 4 above we are unable to provide the information for the period requested as we only started recording the overall compliance rating for each establishment from June 2015. Prior to June 2015 each area had a separate way of recording each establishments audit responses.

The current overall compliance rating system (June 2015 onwards) categorises each establishment as either:

- Good
- Generally Satisfactory
- Improvement Necessary
- Urgent Improvement Necessary

**Therefore we do not have information relating to 'weak' or 'poor' compliance rating.**

**However, based on the current overall compliance rating system categories (June 2015 onwards), I can provide information relating to 'Improvement Necessary' and 'Urgent Improvement Necessary' from June 2015 up to April 2017 as well as the reasons for these categories being given.**
