In the Food and You 2: Wave 1 data tables the base description in the tables for EVCOOK (*'All online respondents who have some responsibility for food preparation or cooking for their household, or for themselves'*) is inaccurate.

The correct base description is *'All online respondents where someone else generally does the food preparation and cooking for the household, or they don't know who does it.'*

This applies to Tables 1610 to 1619 in the All Countries workbook, Tables 1610 to 1619 in the Northern Ireland workbook, Tables 1610 to 1619 in the Wales workbook, and Tables 1770 to 1780 in the England workbook

The tables have not been reproduced with the correct description.
