Annex B

Some of the information requested has been withheld under section 40 of the FOI Act as follows:

a) Section 40(2) exempts personal information from disclosure if that information relates to someone other than the applicant, and if disclosure of that information would, amongst other things, contravene one of the data protection principles in Article 5(1) of the General Data Protection Regulations and section 34(1) of the Data Protection Act 2018.

In this case, we believe disclosure would contravene the first data protection principle, which provides that processing of personal data is lawful and fair. We have considered the legitimate interests of all parties in disclosure of this information and have found that on balance there is not an overriding legitimate interest in disclosure that outweighs the reasonable expectations of privacy of the individual concerned.

Section 40(2) is an absolute exemption and the FSA is not obliged to consider whether the public interest favours disclosing the information.

b) Some of the information you requested is being withheld under section 40(2) of the Freedom of Information Act 2000 because the numbers in those categories are fewer than five. We cannot provide details where the numbers are fewer than five as the individuals concerned in these groups could be identifiable.
