FREEDOM OF INFORMATION REQUEST - CORRIGENDUM TO FOI 2141

Thank you for your email of 18 January 2018 seeking clarification on aspects of the FSA's response of 10 January 2018, specifically whether any other relevant foreign travel or costs had inadvertently been excluded. You asked the following:

Please confirm whether the information you have provided is "the total cost of foreign (i.e. outside of the UK) travel associated with the ROF programme". This would include all trips funded by the FSA including those undertaken by FSA board members or third parties. If there are costs that are not included in your original reply please can you provide these details. My original request asked for subsistence costs, which were not included in your response. Could you please provide the relevant costs per person, per travel?

Please can you confirm that "all foreign travel visits (i.e. outside of the UK) associated with the ROF programme have been included in your original response and that there have been no other visits omitted, for example visits to the Nordic nations and the USA.

FSA Reply

We have carefully reviewed for accuracy the information contained in our response of 10 January 2018 and it has come to light that we omitted to include costs relating to a ROF associated trip to Norway that took place last October. This was clearly an omission on our part. Please therefore accept our apologies. This has now been rectified and information related to this trip has now been provided in the table below and used to calculate the total figure of foreign travel associated with the ROF programme. I can also clarify that individual subsistence costs (where applicable), have also been reflected in the Accommodation/Travel and Subsistence column.

You also specifically draw attention to any USA trips that may have been excluded from the original set of information provided. You may have been alluding to the FSA's attendance at a major international food safety conference in Houston, Texas, between 28 February 2017 – 2 March 2017. I would therefore like to clarify that the FSA's invitation to attend this event, along with our counterparts in other EU member states and third countries, was directly linked to the FSA's statutory role as the UK's Competent Authority for Food Safety and not specifically related to ROF programme business. Attendance at this event therefore remains outside the scope of this FOI request. There are no other ROF - related foreign trips undertaken either by FSA officials, FSA Board members or third parties that fall within the scope of your request.
