#### 1. INTRODUCTION


1.1 This report, which covers the period 1 April 2013 to 31 March 2014, provides a summary of local authority (LA) food law enforcement activity within food businesses in Northern Ireland and on the Food Standards Agency's (FSA) audit of Northern Ireland authorities. #### 2. ESTABLISHMENT PROFILES


2.1. As at 31 March 2014, a total of 20,507 food establishments were registered with LAs in Northern Ireland, an increase of 3.6% on 2012/13 (19,785).

2.2 A comparison of establishment types over the past three years indicates a gradual reduction in the number of retailers, whilst the number of restaurants and caterers; distributors / transporters; and manufacturers and packers has risen year on year.



A comparison of the split between risk ratings in food establishments indicates a reduction of 5.2% in premises rated A and B in 2013/14 (from 860 in 2012/13 to 815) and an increase of 0.9% in premises rated C to E (from 15,730 in 2012/13 to 15,878).



# Establishments Not Yet Rated<sup>1</sup>

2.4 In Northern Ireland, 5.3% of registered food establishments were not yet rated (NYR) for food hygiene risk as at 31 March 2014 (1,088 out of 20,507). This is an improvement on the 2012/13 figure of 6.0% (1,191 out of 19,785).

2.5 There has been an increase in the number of LAs in Northern Ireland reporting levels of NYR establishments below 5% (53.8% of LAs, compared with 50.0% in 2012/13); however this is below the UK average of 62.1%. There were no LAs with levels of NYR above 15% in Northern Ireland as at 31 March 2014.


#### 3. LOCAL AUTHORITY INTERVENTIONS

# **Food hygiene interventions**


3.1 During 2013/14, 19,681 food hygiene interventions were carried out in Northern Ireland, an 8.1% increase on the reported number in 2012/13 (18,204).

3.2 Inspections and audits remain the most frequent food hygiene intervention type (50.3%, compared with 50.6% in 2012/13). The split between all types of intervention remains similar to previous years.



3.3 The percentage of due food hygiene interventions achieved has remained at a level exceeding 90% across all risk rating categories in Northern Ireland. This compares favourably with the rest of the UK.




#### Food standards interventions


During 2013/14, 6,991 food standards interventions were carried out in Northern Ireland, a 16.8% increase on the reported number in 2012/13 (5,984) reversing the decline in previous years.

3.5 As in previous years, inspections and audits were the most prevalent food standards intervention type carried out in 2013/14 although the percentage rate is lower than previous years. However there has been an increase in the percentage of verification and surveillance; sampling visits; and information / intelligence gathering.



3.6 The percentage of due food standards interventions achieved has remained at a level exceeding 90% across all risk rating categories in Northern Ireland. This compares favourably with the rest of the UK.






# Food hygiene enforcement actions

4.1 In 2013/14, 6,259 food hygiene enforcement actions were reported in Northern Ireland, 6,119 written warnings and 140 other 'official' enforcement actions.

4.2 This is an increase of 9.6% on 2012/13 (5,712), although numbers of some types of enforcement action have decreased.






#### Food standards enforcement actions

4.3 In total 1,276 food standards enforcement actions were reported in Northern Ireland in 2013/14, 1,264 written warnings and 12 other 'official' enforcement actions.


4.4 This is an increase of 15.8% on 2012/13 (1,102) although this is due to an increase in the number of written warnings, all other types of food standards enforcement have decreased.



#### 5 OFFICIAL FOOD SAMPLES


5.1 A total of 8,291 official food samples were taken in Northern Ireland in 2013/14, a decrease of 0.9% (from 8,364) on 2012/13. The number of analyses decreased by 0.3% although there was a 2.9% increase in compositional analyses carried out. This varies from the overall UK trend representing a 3.0% increase in sampling activity compared with 2012/13.


#### 6 CONSUMER COMPLAINTS ABOUT FOOD AND FOOD ESTABLISHMENTS

- 6.1 LAs in Northern Ireland dealt with a total of 1,530 consumer complaints about food and food establishments during 2013/14, a decrease of 3.9% (from 1,592) on 2012/13.
- The levels of complaints in relation to food safety and food quality decreased by 39.7% and 7.0% respectively on 2012/13 data; whereas the number of complaints about hygiene of premises increased by 16.9% in comparison with 2012/13. In each case, this reverses the trend from the previous year.




# 7 FULL TIME EQUIVALENT (FTE) PROFESSIONAL LA STAFF

7.1 LAs in Northern Ireland reported a total of 119 FTE professional LA staff in post as at 31 March 2014. Although this would appear to show a 13.1% decrease on 2012/13 figures (137), based on the achievements by LAs in Northern Ireland across Official Controls, this would appear to be due to inaccuracies in the calculation of FTEs that have now been corrected, rather than an actual reduction in resources.



#### 8 FOOD HYGIENE COMPLIANCE

8.1 The level of Broad Compliance in Northern Ireland as at 31 March 2014 was 94.7% of rated establishments (88.9% of all establishments), compared with a 91.7% level across the UK. This is an increase on the 2012/13 level in Northern Ireland of 94.4% of rated establishments (88.0% of all establishments).
