1. INTRODUCTION

1.1 This report, which covers the period 1 April 2013 to 31 March 2014, provides a summary of local authority (LA) food law enforcement activity within food businesses in Wales and on the Food Standards Agency's (FSA) audit of Welsh LAs. 

2. ESTABLISHMENT PROFILES


2.1. As at 31 March 2014, a total of 33,840 food establishments were registered with LAs in Wales, a decrease of 0.2% on 2012/13 (33,917).

2.2. A comparison of establishment types over the past three years indicates a gradual reduction in the number of registered primary producers; manufacturers and packers; and retailers whilst the number of restaurants and caterers has risen year on year.



2.3. A comparison of the split between risk ratings in food establishments indicates a reduction of 3.3% in premises rated A to C in 2013/14 (from 15,873 in 2012/13 to 15,357) and an increase of 6.1% in premises rated D and E (from 15,925 in 2012/13 to 16,894).1.

Establishments Not Yet Rated.²

2.4. In Wales, 3.0% of registered food establishments were not yet rated (NYR) for food hygiene risk as at 31 March 2014 (1,015 out of 33,840). This is an improvement on the 2012/13 figure of 4% (1,358 out of 33,917).

2.5 There has been an increase in the number of LAs in Wales reporting levels of NYR establishments below 5% (72.7% of LAs compared with 63.6% in 2012/13). There were no LAs with levels of NYR above 15% in Wales as at 31 March 2014.


3. LOCAL AUTHORITY INTERVENTIONS

Food hygiene interventions


3.1. During 2013/14, 30,689 food hygiene interventions were carried out in Wales, a 6.5% increase on the reported number in 2012/13 (28,822).

3.2. Inspections and audits remain the most frequent food hygiene intervention type (59.7%, compared with 60.6% in 2012/13). The levels of verification and surveillance visits have reduced slightly to 19.0% (from 22.9% in 2012/13). However, there has been an increase in sampling visits to 7.5% (from 6.0% in 2012/13), advice and education interventions to 9.5% (from 7.0% in 2012/13) and in information/intelligence gathering activity to 4.3% (from 3.4% in 2012/13).



3.3 The trend for LAs to target higher risk establishments (Category A to C) for food hygiene intervention, at the expense of due interventions at lower risk establishments has continued, although figures for Wales were higher than the UK average across all risk rating categories.




Food standards interventions


3.4 During 2013/14, 10,548 food standards interventions were carried out in Wales, an 18.0% increase on the reported number in 2012/13 (8,940) reversing the decline in previous years.

3.5 As in previous years, inspections and audits were the most prevalent food standards intervention type carried out in 2013/14.



3.6 LAs have continued to target higher risk establishments (Category A) for food standards interventions across much of the UK. The figures for Wales are slightly higher than the UK average.




4. ENFORCEMENT ACTIONS

Food hygiene enforcement actions


4.1 In 2013/14, 13,418 food hygiene enforcement actions were reported in Wales, 12,845 written warnings and 573 other 'official' enforcement actions (see Figure 4.1). This is an increase of 0.4% on 2012/13 (13,358), although some types of enforcement action have shown decreases (see Figure 4.2).


³ From 1 May 2012 enforcement officers in Wales have been able to use Remedial Action Notices to secure compliance at all food establishments. They were previously only available for use in approved premises.



Food standards enforcement actions

4.2 In total 1,121 food standards enforcement actions were reported in Wales in 2013/14, 1,041 written warnings and 80 other 'official' enforcement actions (see Figure 4.2). This is an increase of 2.7% on 2012/13 (950), although some types of enforcement action have shown decreases (see Figure 4.4).


Figure 4.3: Number of establishments subject to food standards enforcement actions in Wales 2013/14

5. OFFICIAL FOOD SAMPLES


- A total of 8.736 official food samples were taken in Wales in 2013/14, an increase of 19.8% from 2012/13, compared with a UK wide increase of 3.0%.
- 5.2 Microbiological food sampling is coordinated through the Welsh Food Microbiological Forum. The WFMF is a collaboration of public health organisations and local authorities in Wales with FSA representation. The aim is to improve the microbiological quality of food available to Welsh consumers. This is achieved by using the innovative "shopping basket" protocol with a nominated list of foods of interest and by completing targeted surveys that address current food related issues.
- 5.3 Food standards sampling in Wales is coordinated through the Wales Head of Trading Standards Food and Agriculture Panel. LAs, Public Analysts and the FSA are represented on the Panel, which participates in the National Coordinated Food Sampling Programme.


6. CONSUMER COMPLAINTS ABOUT FOOD AND FOOD ESTABLISHMENTS

6.1. Welsh LAs dealt with a total of 3,928 consumer complaints about food and food establishments during 2013/14, an overall increase of 8.4% (from 3,622) on 2012/13. There was a large increase (19.7%) in food safety complaints in Wales, compared with an overall decrease of 0.2% across the UK.




7. FULL TIME EQUIVALENT (FTE) PROFESSIONAL LA STAFF

7.1. A total of 216 FTE professional LA staff was reported as being in post at 31 March 2014, a comparable figure to that reported for 2012/13 (215).



8. FOOD HYGIENE COMPLIANCE

8.1. The level of Broad Compliance in Wales as at 31 March 2014 was 91.8% of rated establishments (89.0% of all establishments), compared with a 91.7% level across the UK. This is an increase on the 2012/13 level in Wales of 88.0% of rated establishments (84.4% of all establishments).



9. AUDIT OF COMPETENT AUTHORITIES
